

ARTICLES OF INCORPORATION

OF

A FAMILY AFFAIR PERSONAL SERVICES, INC.

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby associates herself to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is:

A FAMILY AFFAIR PERSONAL SERVICES, INC.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is pet care and house sitting; and to engage in every and any respect and phase of any and every lawful business, including, but not limited to, the following activities:
