ARTICLE I

The name of this corporation shall be QVS Insurance Agency, Inc.

ARTICLE II

The term of existence of the Corporation is perpetual, unless sooner dissolved according to law.

The Corporation's existence shall commence upon the filing of these Articles of Incorporation with the Department of State of the State of Florida.

ARTICLE III

The purpose for which the Corporation is organized is the transaction of any and all lawful business for which corporations may be organized to transact, and to do such other things as are incidental, necessary or desirable in order to accomplish the same.

ARTICLE IV

The shareholders(s) of the Corporation shall include in the By-Laws or enter into an agreement for, restrictions regarding the sale, transfer or other disposition of any of the outstanding or unissued stock of the Corporation by the shareholder(s).

ARTICLE XV


The shareholders(s) expressly reserve the right to dissent to any merger.

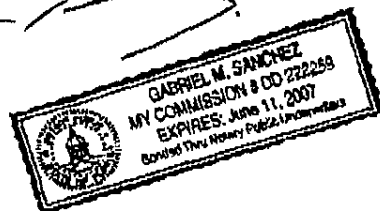
