OF

The undersigned hereby makes and subscribes to these Articles of Incorporation intending to form a professional service corporation (the "Corporation") under the provisions of the Florida Statutes.

ARTICLE I - NAME

The name of this Corporation is LAING & LANDOLFI, P.A.

ARTICLE II - PURPOSE

The Corporation may engage in every phase and aspect of the business of rendering the same professional services to the public that an attorney at law, duly licensed under the laws of the State of Florida, is authorized to render. The Corporation shall carry out the above professional services through duly licensed or otherwise lawfully authorized attorneys at law.

The Corporation shall have all the powers conferred upon this Corporation by the laws of the State of Florida or of any other state or country not prohibited by the Professional Service Corporation Act.

ARTICLE III - SHARES

The aggregate number of shares which the Corporation shall have the authority to issue shall be 10,000 at \$1.00 par value common shares.

ARTICLE IV - PRINCIPAL OFFICE AND MAILING ADDRESS

The initial principal place of business and mailing address of the Corporation shall be 445 East Palmetto Park Road, Boca Raton, Florida 33432.

ARTICLE VI - INITIAL DIRECTORS

The number of Directors constituting the initial Board of Directors of this Corporation is **Two (2)**. The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the Corporation, but shall never be less than one (1). ARTICLE IX - CORPORATE BUSINESS AND AFFAIRS

Anything to the contrary contained in these Articles of Incorporation notwithstanding, if the Shareholders of the Corporation shall so elect, they may exercise all powers and conduct the business and affairs of this Corporation in lieu of the Board of Directors.

ARTICLE X - RESIDENCY AND COMPENSATION OF DIRECTORS

Directors of this Corporation need not be residents of the State of Florida, unless otherwise provided in the Bylaws of the Corporation. The Shareholders of this Corporation shall have exclusive authority to fix the compensation of Directors of this Corporation, unless otherwise provided in the Bylaws.

Members of the Board of Directors may participate in regular or special meetings of the Board of Directors by means of a telephone conference as provided by law.


ARTICLE XII - RESTRICTION ON TRANSFER OF SHARES

The effective date of the Corporation shall be March 5, 2007.


