Pursuant to the provisions of the Professional Services Corporation Act of the State of Florida the undersigned Shawn L. Hartsfield, being a duly licensed Certified Public Accountant does hereby make, organize and form a professional service corporation under the following Articles of Incorporation to wit:

ARTICLE I - NAME

The name and address of the corporation is:

The corporation shall have perpetual existence. This corporation's existence shall commence of the date of execution and acknowledgment of these articles.
