



The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The name of the corporation (hereinafter called the "Corporation") is WBW Consulting, Inc.

SECOND: The principal office of the Corporation shall be located at 15401 S.W. 77th Ave., Miami, FL 33157. The mailing address of the Corporation is 15401 S.W. 77th Ave., Miami, FL 33157.

THIRD: The aggregate number of shares which the Corporation shall have authority to issue is 1,000, all of which are of a par value of \$0.01 each and are of the same class and are to be common shares.

FOURTH: The number of directors constituting the initial Board of Directors of the Corporation is one which may be increased or decreased by the bylaws.
