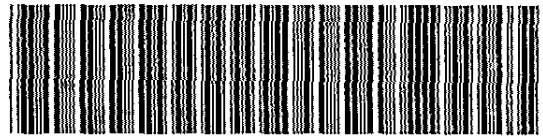



In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the Corporation ("Corporation") is MASTERS L.S., INC.

ARTICLE II - PRINCIPAL OFFICER

The street and mailing address of the initial principal office of the Corporation is 909 North SR 19, Palatka, Florida 32177.

ARTICLE III - EXISTENCE

The existence of the Corporation shall begin on 19 February 2007.

ARTICLE IV - STOCK

The maximum number of shares this Corporation is authorized to issue is 100 with no par value. All of which shall be common shares. All common shares shall be identical with each other in every respect and the holders of common shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.
