ARTICLES OF INCORPORATION OF TECH SYSTEMS ONLINE, INC.

ARTICLE I

NAME

The name of this corporation is:

Tech Systems Online, Inc.

ARTICLE !!

DURATION

This corporation is to exist perpetually. It shall commence its existence upon the filing of these Articles of Incorporation.

ARTICLE III

PURPOSE
