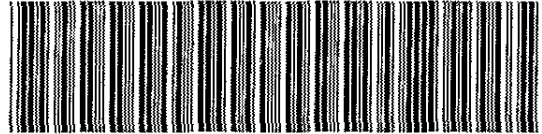

**ARTICLES OF INCORPORATION**

**OF**

**N.B.C. INVESTMENT CORPORATION**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

**ARTICLE I.-** The name of the corporation is: **N.B.C. INVESTMENT CORPORATION.**

**ARTICLE II.-** The duration of the corporation is perpetual.

**ARTICLE III.-** The purposes for which the corporation is organized are:

- A. To carry on and transact any lawful business.
