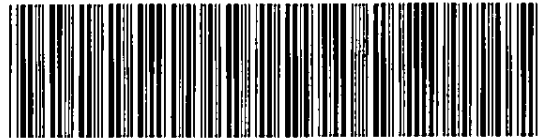

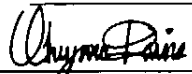

**ARTICLES OF CORRECTION OF
QUINTE FINANCIAL TECHNOLOGIES INC.**

**PURSUANT TO SECTION 607.0124(1)
OF THE FLORIDA BUSINESS CORPORATION ACT**

1. The Articles of Incorporation of Quattro Risk Management Inc. ("Quattro") were filed with the Secretary of State of Florida on March 8, 2007.
2. The Articles of Incorporation of Quattro were subsequently amended to change its name to Quinte Financial Technologies Inc.
3. The Articles of Incorporation of Quattro contained an inaccuracy that was recently discovered.
4. The inaccuracy was contained in Article IV of the Articles of Incorporation in which it was stated that the number of shares Quattro was authorized to issue is 500.
5. Article IV of the Articles of Incorporation should be corrected to state that the number of shares Quattro is authorized to issue is 500,000.
