

SECOND: The jurisdiction where the above named corporation was first formed, incorporated, or otherwise came into being was North Dakota;



OF

ARTICLE 1. NAME

The name of the Corporation is:

ARTICLE 2. DURATION

The duration of the Corporation is perpetual.

ARTICLE 3. PURPOSES

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act; and
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.


ARTICLE 8. COMMENCEMENT OF EXISTENCE
