

**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
RIBBON NATURALS CORPORATION**

RIBBON NATURALS CORPORATION, a Florida corporation (the "Corporation") whose Articles of Incorporation were originally filed with the Florida Department of State on March 12, 2007 (Florida Division of Corporations Document Number P07000031307), hereby certifies as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article One, as previously may have been amended, in its entirety and by substituting, in lieu thereof, the following:

"ARTICLE ONE

The name of the corporation shall be:

PURE SOLUTIONS, INC."

2. The foregoing amendment shall become effective as of the close of business on the date these Articles of Amendment are approved by the Florida Department of State and all filing fees then due have been paid, all in accordance with the corporation laws of the State of Florida.
