The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

**ARTICLE I. - NAME**

The name of this corporation is STRICKLY RUSSIAN CAVIAR, INC.

**ARTICLE II. - NATURE OF BUSINESS**

The corporation may engage in activity of business which is permitted under the laws of the United States and of the State of Florida.



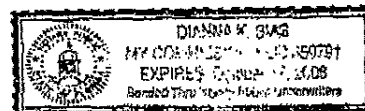
