ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Mr. Prepaid, Inc. Its principal office address and business mailing address is Aventura Corporate Center II, 20803 Biscayne Boulevard, Suite 305, Aventura, Florida 33180.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE


