ARTICLE I  
NAME AND ADDRESS

The name of the corporation is PRIMARY PROVIDER, INC. (the "Corporation"). The address of the principal office of the Corporation shall be 9193 Sunset Drive, Suite 210, Miami, Florida 33173. The mailing address of the Corporation shall be the same as the address of the principal office.

ARTICLE II  
DURATION

The Corporation shall have a perpetual existence commencing upon filing of the Articles of Incorporation with the Secretary of State.


