**"ARTICLE I - Name**

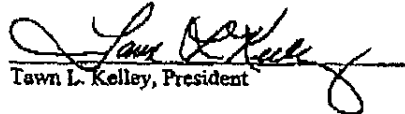
The name of the corporation is MHF, Inc."
