**ARTICLES OF INCORPORATION
FOR
CUSTOM GARAGES, INC.**

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME AND PRINCIPAL OFFICE**

The name of the corporation shall be **Custom Garages, Inc.**, and its principal office is located at 3462 Ashmore Lane, Pace, Florida 32571.

**ARTICLE II
DURATION**

This corporation shall exist perpetually, commencing April 7, 2007.




