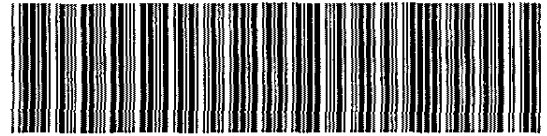

The undersigned, for the purpose of forming a for-profit corporation under the laws of the state of Florida, do hereby adopt the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation shall be **Rose Diva Inspirational Poetic Collections, Inc.** (hereinafter called the "Corporation")

ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS
