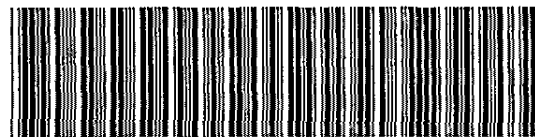


AMENDMENT
