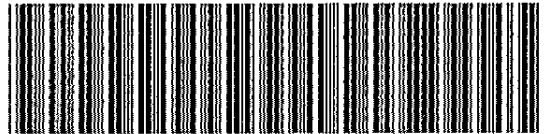

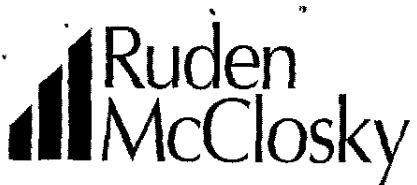

ARTICLES OF INCORPORATION
OF
JUPITER PRIMARY CARE GROUP, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Jupiter Primary Care Group, Inc. and its address is Suite 111, 9121 North Military Trail, Palm Beach Gardens, Florida 33410.

ARTICLE II

DURATION

The duration of the corporation is perpetual.


