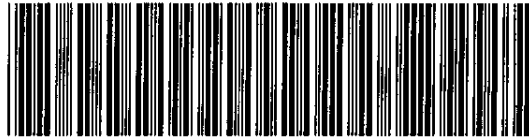

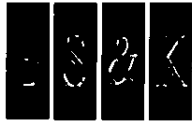

ARTICLE 1. NAME

The name of the Corporation is:
