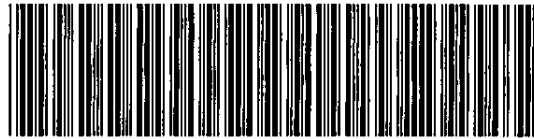

**ARTICLES OF INCORPORATION**  
**OF**  
**ATLANTIC PULMONARY AND SLEEP ASSOCIATES, P.A.**

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

The name of this corporation is ATLANTIC PULMONARY AND SLEEP ASSOCIATES, P.A., with its principal office located at 810 Wild Wood Avenue, Daytona Beach, Florida, 32117.

**ARTICLE II**

This corporation shall exist until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.

**ARTICLE III**

The corporation is authorized to issue 1000 shares of common stock having no par value.

**ARTICLE IV**

The general nature of the business to be transacted by this corporation is as follows:

(a) To establish, manage, and operate a professional services corporation providing pulmonary critical care and sleep disorder evaluation, examination, treatment, and care including all activities necessary for the establishment and operation of said profession.

(b). To have a seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any manner reproduced.

(c). To purchase, take, receive, lease, sub-lease or otherwise acquire, own, hold, improve, use, and otherwise deal in and with the real and personal property or any interest therein, wherever situated.

(d). To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer and otherwise dispose of all or part of its property and assets.

(e). To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises and income.

(f). To lend money for its business purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.

(g). To conduct its business, carry on its operations, and have offices and exercise the powers granted by this act within or without this state.

(h). To make distribution for the public welfare or for other charitable, scientific or educational purposes.

(i). To pay pensions and establish pension plans, profit sharing plans, stock bonus plans, stock option plans and other incentive plans for any and all of its directors and officers.

(j). To be a promoter, incorporator, partner, member, associate or manager of any corporation, partnership, joint venture, trust or other enterprise.

(k). To have, exercise and enjoy all of the rights and privileges of corporation for profit as conferred by the laws of the State of Florida, it being expressly provided that the enumeration of the specific powers and purposes shall not be held to limit or restrict in any manner the general powers of the corporation except that all such activities shall be directed toward ownership and operation of a pulmonary critical care and sleep disorder practice.

## **ARTICLE V**

The mailing address of the principal office of this corporation is 810 Wildwood Avenue, Daytona Beach, Florida, 32117, and the name of the registered agent of this corporation is Barry E. Hughes whose address is 2001 South Ridgewood Avenue, South Daytona, Florida, 32119.

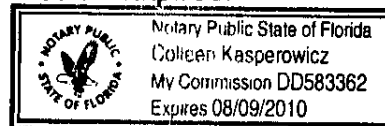
