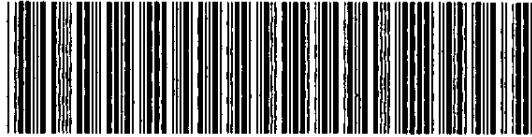

This letter requests a cancellation/inactivity of my company Louback Flooring, Inc. as of today August 26, 2008 due to the following reasons:




