Laura Angelica Regalado, being of the age of eighteen (18) years old or more, does hereby make and acknowledge these Articles of Incorporation under and by virtue of the laws of the State of Florida.

- 1. The name of the Corporation shall be: Inversiones Miami Beach, Inc. in English meaning Investments Miami Beach, Inc.**
- 2. The number of shares the corporation is authorized to issue shall be 1000 shares all of one class designated as common stock, at \$1.00 per value.**
- 3. The street address and county of the initial principal office of the corporation is: 14105 SW 46th Ter Miami, Fl. 33175, Miami-Dade County and the name of the initial register agent at this address is: Laura Angelica Regalado at the same address.**
