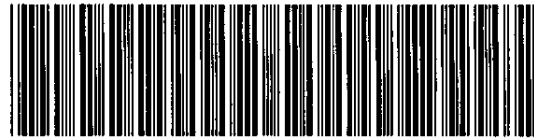


ARTICLE V: REGISTERED AGENT


