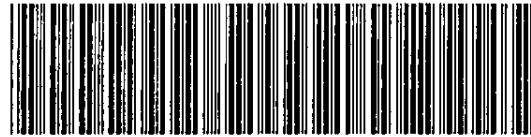

ARTICLE III


The date dissolution was authorized is December 31, 2010. The effective date of dissolution will be December 31, 2010.
