

Pursuant to F.S. 607.0202, the undersigned incorporator does hereby submit these Articles of Incorporation for the purpose of forming a Florida profit corporation.

ARTICLE I

The name of the corporation is Advanced Industrial Aeration, Inc..

ARTICLE II

The period of duration of the corporation shall be perpetual.

ARTICLE III

The corporation is organized to conduct any and all lawful businesses.

ARTICLE IV

The aggregate number of shares which the corporation shall have the authority to issue is 1,000,000 divided into one class.
