We, the undersigned, all of whom are of legal age, do hereby associate ourselves for the purpose of becoming a corporation.

ARTICLE I

NAME

The name of this corporation shall be;
EMOTIONAL IMPACT, INC.

ARTICLE II

GENERAL NATURE OF BUSINESS

This corporation is organized to conduct and operate any and all other kind of business or affairs authorized by the laws of the State of Florida and of the United States of America.
