WE, the undersigned hereby ourselves together for the purpose of becoming a corporation under the law of the State of Florida providing for the formation of a corporation for profit, with the powers, right, privileges and immunities hereinafter mentioned, and we hereby make, subscribe and acknowledge and file with the Secretary of State of Florida this certificate of incorporation; to that end we do, by this Certificate set forth:

ARTICLE I

The name of this corporation which is hereinafter called the "Corporation"

ARTICLE II

This Corporation is organized for the purpose of transacting any or all business permitted under the laws of the United State of America and the laws of the State Of Florida, and to do any and all of the things hereinafter mentioned as fully and to the same extent as natural persons might or could do, to wit:

No contract or other transaction between this Corporation and any other corporation, and no act of this Corporation shall in any way be effected or invalidated by the fact that any of the directors of the Corporation are pecuniarily or otherwise interested in, or are directors or officers of, such other corporation, any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of the Corporation, provided that the fact that he or such firm so interested or shall have been known to the Board of Directors or such member thereof as shall be present at any meeting of the Board at which action upon any such contract or transaction shall be taken; and any director of the Corporation who is also a director or officer of such other corporation or is so interested may be counted in determining the existence of a quorum at any meeting of
