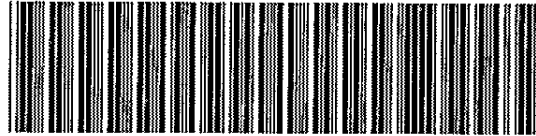

The undersigned incorporators of these Articles Of Incorporation, each a natural person competent to contract, hereby subscribe themselves to these Articles Of Incorporation under the laws of the State of Florida.

Article I - Name

The name of this Corporation is: **CLEAN ENERGY SUPPLIES, INC.**

Article II - Purpose

This Corporation is organized for the purpose of:

- (1) Manufacturing and/or selling equipment, parts and supplies associated with the production of renewable energy;
- (2) Conducting research associated with the production of renewable energy;
