The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form & Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I - NAME
The name of this corporation is

ARTICLE II - DURATION / TERM OF EXISTENCE

ARTICLE VII AMENDMENT

These articles of Incorporation may be amended in the manner provided by law. ARTICLE IX POWER OF CORPORATION
