The undersigned hereby makes and subscribes to these Articles of Incorporation intending to forth a Corporation under the provisions of the Florida Statutes.

ARTICLE I

Any such agreements will be valid and enforceable among the parties to such agreements and, when the existence of such agreement is noted on the face or on the back of the certificates representing any such shares, such agreements will be binding and enforceable upon any transferee or successor of any party to such agreement.
