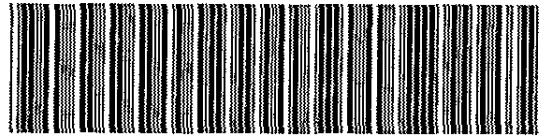

FILED

FIRST: The name of the Corporation is BLUE RIBBON INVESTMENT CO.

SECOND: This Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be formed under Chapter 607 of the Florida Statutes.

THIRD: The Corporation shall have one class of common stock. The maximum number of shares of common stock that this Corporation is authorized to issue and have outstanding at any one time shall be as follows:

Twenty-Five (25) shares of voting common stock with a par value of One Hundred (\$100.00) Dollars; and


EIGHTH: The duration of this Corporation is perpetual.
