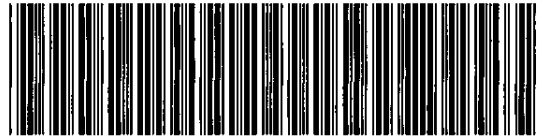

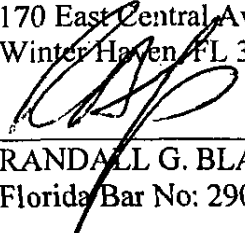

ARTICLE VII

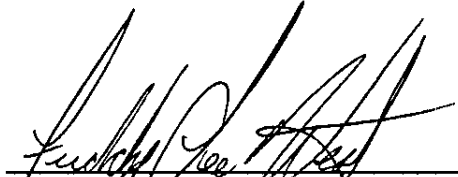
