

(In compliance with Chapter 607 and/or Chapter 621, F.S. [Profit])

Article I. NAME

1. We the founders and undersigned hereby incorporate "MiamiWarCanoe Inc." as an S corporation for the purpose of providing a publication of similar name to and for the people of the city of Miami in the great state of Florida.

Article II. PRINCIPAL OFFICE

1. The principal place of business for MiamiWarCanoe Inc. will be the city of Miami, Florida. Its mailing address is; 1527 Albenga Ave. Suite 3-101D, Coral Gables, FL 33146.

Article III. PURPOSE

1. The Specific Purpose of MiamiWarCanoe Inc. shall be to provide for a publication to the people of Miami, FL and protect its owners and agents.

Article IV. SHARES

1. MiamiWarCanoe Inc. is authorized to have 100,000 shares of preferred stock and 100,000,000 shares of common stock.

4. Issuance of stock in the corporation must be approved by both founders under any and all circumstances.
5. The founders of MiamiWarCanoe Inc. shall be equal equity owners in the corporation at the time of Incorporation by the issuance of half of all shares of preferred stock to each founder in exchange for a monetary amount of \$0.00001 per share to be paid into the corporate bank account upon creation.




