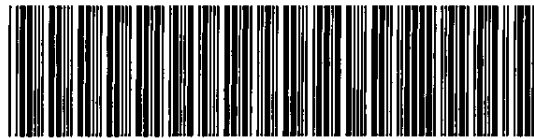

The Name of the Corporation is BRIARWOOD CONSTRUCTION AND REMODELING INC.
