**ARTICLES OF INCORPORATION  
OF

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida. Providing for the formation, right, privileges, immunities, and liabilities of incorporation for profit.

**ARTICLE I**

The name of the corporation should be:
