



The undersigned, for the purpose of forming a sub-chapter "S" corporation Under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is:

LANDSCAPE SERVICES INC. USA.
2824 Gocio rd.
Sarasota, Florida 34235

Article 2. Duration. The duration of the Corporation is perpetual: The Corporation is to commence APRIL 1, 2007

Article 3. Purpose. The general purposes for which the corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such things as are incidental to the purpose of the Corporation or necessary or desirable in order to accomplish them.

Article 4. Capital Stock.

The aggregate number of shares which the Corporation is authorized to issue is 1,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

Article 5. Initial Registered Office and Agent.

The street address of the initial Registered Office of the Corporation is 2824 Gocio Road, Sarasota, Florida 34235, and the name of its initial Registered Agent at that address is Eric C. Witte.

Article 6. Initial Board of Directors.






