**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF

Pursuant to Section 607.1006 of the Florida Business Corporation Act, the undersigned, being the Chief Executive Officer of THE RECOVERY PLACE, INC., a Florida corporation (the "Corporation"), bearing Document Number P07000038174, does hereby submit these Articles of Amendment for the purpose of amending the Corporation's Articles of Incorporation as follows:
