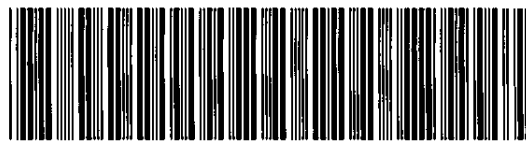

Article XIII – Amendment



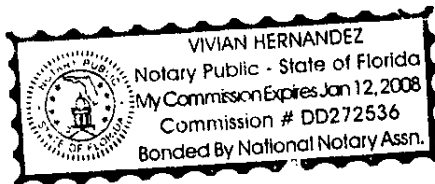
