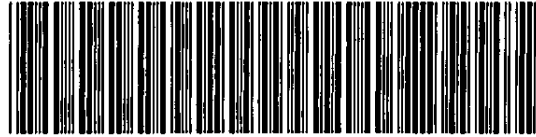

**ARTICLE ONE**

The name of this corporation is LAWN MEDIC OF SW FLORIDA, INC. and the mailing address of the corporation shall be 3371 Cleveland Road, Suite 308, South Bend, IN 46628.

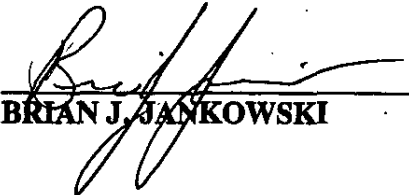

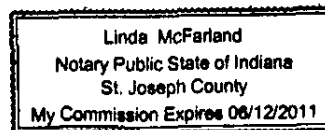
