These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida Business Corporation Act. as particularly set forth in Chapter 607 of the Florida Statutes.

ARTICLE 1 NAME AND ADDRESS

The name of this corporation shall be EVERGLADES PINESTRAW, INC. The initial principal business address of the corporation is 1860 Boy Scout Drive, Suite 206B, Fort Myers, Florida 33907,

ARTICLE 2 DURATION

The corporation shall commence upon the filing of these Articles and shall have perpetual existence thereafter.

ARTICLE 3 PURPOSE

The purpose for which the corporation is organized is the transaction of any and all lawful business for which a corporation may be incorporated under the Fiorida Business Corporation Act, as the same may from time to time be amended.

ARTICLE 4 CAPITAL STRUCTURE
