



The Amended and Restated Articles of Incorporation of Transcor Services Corp., a Florida corporation incorporated under the provisions of the Florida Business Corporation Act (the "Act"), shall read in their entirety as set forth below:

#### ARTICLE 1 Name

The name of this corporation (hereinafter called the "Corporation") is: Transcor Services Corp.

#### ARTICLE 2 Duration

The duration of the Corporation shall be perpetual.

### ARTICLE 3 Principal Office and Mailing Address

The street address of the principal office and the mailing address of the Corporation is 1501 E. 2nd Avenue, Tampa, Florida 33605.

#### **ARTICLE 4** Capital Stock

- Number of Shares. The Corporation is authorized to issue One Thousand (1,000) shares of (a) Common Stock, par value \$0.001.
- Voting Rights. Except as otherwise provided by the Florida Business Corporation Act, the **(b)** entire voting power of the shares of the Corporation for the election of directors and for all other purposes shall be vested exclusively in the Common Stock.
- (c) Dividends. ### ARTICLE 6 Indemnification

The Corporation shall, to the fullest extent permitted by the provisions of the Florida Business Corporation Act, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said provisions from and against any and all expenses, liabilities, or other matters referred to in or covered by said provisions, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under the Bylaws of the Corporation, vote of shareholders or disinterested directors, or otherwise, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person. No director of the Corporation shall be personally liable to the Corporation or its shareholders for any monetary damages for breaches of fiduciary duty as a director, provided that this provision shall not climinate or limit the liability of a director under Section 607,0831 of the Florida Business Corporation Act.

Only a majority in interest of the Common Stock shall have the exclusive power, at any time, and from time to time, to adopt, amend and repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and the Bylaws of the Corporation.
