

ARTICLES OF INCORPORATION OF WS ADMINISTRATOR, CORP.

The undersigned hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be WS Administrator, Corp. The address of the principal office of this corporation shall be 1500 San Remo Avenue, Suite 125, Coral Gables, Florida 33146, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

Except as provided herein, this corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory, or nation. At any time or times when this corporation is providing services to, or acting as trustee of, any trust, this corporation may engage in providing administrative services to, or act as trustee of, only "family trusts." For this purpose, "family trusts" include only trusts where the beneficiaries are related to the settlor within the fourth degree of affinity or consanguinity. Moreover, this corporation cannot engage in any activity for profit, gain or livelihood, or in any "for profit" venture with respect to providing administrative services to, or acting as trustee of, any trust. This corporation cannot accept compensation for providing administrative services to, or acting as trustee of, any trust, other than reimbursement for outside services provided to the trusts by third parties or for other expenses reasonably incurred in activities authorized herein and in the corporation's bylaws, which are directly related to the provision of administrative services to, and acting as trustee of, family trusts.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 shares of common stock at \$1,00 par value per share.

ARTICLE IV. REGISTERED AGENT

The street address of the initial registered office of this corporation shall be 1500 San Remo Avenue, Suite 125, Coral Gables, Florida 33146, and the name of the initial registered agent of the corporation at that address if Atrium Registered Agents, Inc.

ARTICLE V. TERM OF EXISTENCE

This corporation is to exist perpetually.
