ARTICLES OF INCORPORATION

The undersigned, acting as the Incorporator of MORE PLEASE, INC., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

ARTICLE I - NAME

The name of the Corporation is MORE PLEASE, INC. The initial mailing address of the Corporation shall be 6432 International Drive, Orlando, Florida 32819.

ARTICLE II - CORPORATE EXISTENCE

The Corporation will exist commencing on the date of filing these Articles of Incorporation with the Florida Department of State.

ARTICLE III - DURATION

The Corporation shall exist perpetually.

ARTICLE IV - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful businesses for which corporations may be incorporated under Chapter 607, Florida Statutes.

The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors and the shareholders.




