**ARTICLES OF INCORPORATION
OF

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida. Providing for the formation, rights, privileges, immunities, and liabilities of incorporation for profit.

ARTICLE I

The name of the corporation should be:

The maximum number of shares, which the corporation is authorized to issue and have outstanding at any one time, is 1000 shares of common stock, not par value. All stock is to be issued as fully paid and exempt from assessment.

The pledge, sale, transfer or other disposition of the capital stock may be governed and restricted by the by-laws or written agreement among the stockholders that shall be on file in the office of the corporation.

The amount of capital with which its corporation may begin doing business shall be not less than five hundred dollars (\$ 500.00).

ARTICLE VII

The board of directors may from time to time move the principal office to any other address in the State of Florida.
