ARTICLES OF INCORPORATION OF:

CASSIA & RICARDO CORPORATION

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE VII AMENDMENT

These articles of Incorporation may be amended in the manner provided by law. The Corporation shall have the same powers as an Individual to do all things necessary or convenient to carry out its business affairs, subject to any limitations or restrictions imposed by applicable law or these Articles of Incorporation.
