ARTICLES OF INCORPORATION
For

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is RT Equity Trust Financial, Inc. Principal place of business is 4385 SW 10th Place, Suite 205, Deerfield Beach, FL 33442.

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.
