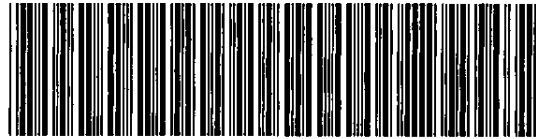

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is 1,000 shares having a \$1.00 par value per share.






