The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

**I.
Name**

The name of the Corporation is **RPE Canada, Inc.**

**II.
Term of Existence**

The date when corporate existence will commence is March 30, 2007 in accordance with Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

These Articles of Incorporation may be amended in the manner provided by law.
