ARTICLES OF INCORPORATION

OF

PHILIP MANDRACCHIA, DDS, AND ASSOCIATES, P.A.

The undersigned does hereby make, subscribe, acknowledge and file these Articles of Incorporation for the purpose of incorporating PHILIP MANDRACCHIA, DDS, AND ASSOCIATES, P.A. (the "Corporation"), a professional corporation under the laws of the State of Florida.

ARTICLE ONE - NAME

The name of the corporation is PHILIP MANDRACCHIA, DDS, AND ASSOCIATES, P.A.

ARTICLE TWO - PRINCIPAL OFFICE AND MAILING ADDRESS

The corporation's principal office shall be located at 1503 Fernando Drive, Unit 2, Tallahassee, Florida 32303, and its mailing address shall be 1503 Fernando Drive, Unit 2, Tallahassee Florida 32303.

ARTICLE THREE - TERM OF EXISTENCE

This corporation shall have perpetual existence, commencing upon the filing of these Articles of Incorporation with the Florida Department of State.

ARTICLE FOUR - GENERAL PURPOSE OF CORPORATION

The general purpose of the corporation and the nature of the business to be transacted by the corporation is the practice of dentistry and the conduct of any and all activities and exercise any and all powers, rights and privileges related thereto for which the corporation may now or hereinafter be organized under the laws of the State of Florida.

ARTICLE FIVE - CAPITAL STOCK

A. The maximum number of shares of any equity security that the corporation is authorized to have outstanding at any time shall be as follows:

- B. One thousand (1,000) shares of common stock with a par value of \$1.00 per share. The whole or any part of the common stock of the corporation shall be payable in lawful money of the United States of America, or in property, labor or services at a just valuation to be fixed by the Board of Directors in its sole discretion.
 - C. Only licensed dentists may be shareholders of this corporation.

<u>ARTICLE SIX – REGISTERED AGENT AND INITIAL REGISTERED OFFICE</u>

The initial registered agent and the street address of the initial registered office of the corporation shall be:

ARTICLE SEVEN - INDEMNIFICATION
